Mode and place of Data processing

Method of processing

The Owner shall take appropriate security measures to prevent unauthorized access, disclosure, alteration or unauthorized destruction of the Data.

Processing of the Data is performed using computers and/or enabled IT tools, following organizational procedures and means strictly related to the stated purposes. In addition to the

Owner, in some cases, Data may be accessed by certain types of persons in charge of, involved in the operation of this Service (this Application) (administration, sales, marketing, legal system administration) or external parties (such as third-party technical service providers, couriers, hosting providers, IT companies, communication agencies) appointed, where necessary, as Data Processors by the Owner. Legal basis for processing
